- 3. To consider a Special Resolution (requiring a 75% majority of those registered to vote) in the name of the Brigade Executive to update the Memorandum & Articles of Association following the separation agreement reached with The Northern Ireland Boys' Brigade:

That Article 1 (Interpretation) of the Articles of Association be amended by adding at the end of the definition of "The Brigade" the following:

EXCEPT THAT, following an agreement between The Brigade and The Northern Ireland Boys' Brigade to be dated on or prior to 31st August 2023 and to be effective from and after 1st September 2023, shall not admit to membership any Company or group which is domiciled in Northern Ireland and 1st Donegal, 1st Dunkineely and 1st Milford Companies having resigned their membership of The Brigade shall not be re-admitted without agreement of The Northern Ireland Boys' Brigade while the said agreement is in force.

4. To consider an Ordinary Resolution in the name of the Brigade Executive to update the Brigade Regulations following the separation agreement reached with The Northern Ireland Boys' Brigade:

That Brigade regulations SECTION THREE be amended as follows:

- a) Regulation 56 by deleting Regulation 56.3 and renumbering the remaining sub clauses accordingly;
- b) Regulation 70 by deleting clause 70.1 (e) iii) and renumbering the remaining sub clauses accordingly; and
- c) By deleting the provisions relating to Northern Ireland in Schedule A.
